Agenda Item 1	Approval of Minutes	Presenter:	Barbara Teusink

1. Barbara Teusink called the meeting to order and asked for approval or corrections to the minutes from last month's meeting. The minutes were approved with no changes.

- 1. ETV recently worked on proving "Substantial Service" use for EBS licenses used for educational services as required by the FCC. All licenses have been approved.
- 2. ETV currently holds 67 licenses. 14 of the licenses do not have a service area, but are transmitter to site only. 2 of these 14 licenses have no significance and ETV has released them, leaving us with 65 valid licenses
- 3. Next month's meeting will be held at ETV, at which time they will give a presentation of the Educational Portal.

E-Rate News

- 1. The annual E-Rate application filing window opened on January 9, 2012 and will close 11:59 EDT March 20, 2012.
- 2. In an effort to safeguard the K-12 Schools and Libraries Network against the potential penalties resulting from E-Rate CIPA incompliance of state consortium participants, the following actions will be taken by the committee to increase awareness of this program requirement among schools/districts/systems:
 - Valarie Byrd previously distributed a draft copy of the Internet Safety Standards
 Memorandum, K-12 Network Certification document and proposed changes to the current
 Bandwidth Allocation Policies to Don Cantrell (SCDE), Dave Goble (SCSL), Rogan Hamby
 (SCSL), Nancy Rosenwald (SCSL) and Tom Fletcher (DSIT) to review.
 - Don Cantrell will handle the distribution of the Internet Safety Standards Memorandum to the K-12 School community. State Library will modify the draft Internet Safety Standards Memorandum to accommodate the Library Systems and handle its distribution.
 - DSIT will distribute the K-12 Network Certification document to all Network members when FCC Form 479's are collected in the spring. Revised Bandwidth Allocation Policies will be ready for committee approval later this funding year.

State E-Rate Program Status

2010-11 (Closed Year) Application

1. DSIT responded to a USAC-PQA audit request for information pertaining to a previously filed BEAR reimbursement. This compliance audit is being done to confirm that proper payment was received from the vendor.

2011-12 (Current Year) Application

1. DSIT has received all Form 486 NL confirmations from USAC. BEAR reimbursements will be filed later this funding year.

2012-13 (New Year) Application

- 1. Four applications were generated the day the application window opened (01/09/12). Two of the four applications have been submitted and the remaining applications (DIA and WAN) are works in progress.
- 2. SDE and SCL will continue reviewing draft technology plans to provide DSIT with outstanding Technology Plan Approval Letters by June 1, 2012.
- 3. SDE has provided a final draft copy of the data collection file and this information was forwarded to all K-12 members.
- 4. QDC1 (45th day of school) counts look better this year and it will be utilized for the E-Rate NSLP data file submission to USAC when requested. Districts were given the option to swap this data with the 90 day drop out counts, but no request to change were received by SDE. These stats will be posted soon via SDE website. Libraries were provided with an Excel spreadsheet containing this information to avoid delays in filing their applications.
- 5. State LOA's (SDE and SCSL) covering 2013-2014, 2014-2015, 2015-2016 will be needed by DSIT before the end of this funding year.
- 6. USAC will be requesting a new state eligibility certification letter and validated NSLP data file from SDE.

Fall Cyber Security Online Challenge Competition

1. All participants were invited to DSIT to tour the state data center on January 24, 2012. Nineteen of the twenty-five participants attended along with five chaperones. This event was a huge success with the group. The group was taken on a tour around the main control room facility by DSIT mangers Tom Tart and Nathan Hogue. The SC ISAC group did a presentation that elicited many questions and interest among the participants. One student stated "This is Awesome!" After lunch the student participants were surprised with certificates signed by Governor Nikki Haley, Jimmy Earley, Jim MacDougall and Valarie Byrd. They also received a Letter of Recognition from James MacDougall denoting their individual accomplishments. Each student was photographed accepting their certificates with Jim and Tom. These photos will be sent to the location contacts and included in a newspaper article that will be distributed by DSIT at a later date. This information was sent to SDE for publishing. The next challenge is scheduled to begin this upcoming March and we hope to see more participants.

Network Changes

- 1. The new Network Services contract was awarded last month. Lot 2 Rates: K-12 Schools network will benefit with reduced rates across the state. Direct impact on network members will result in decreased cost shares. Most will more than likely purchase additional bandwidth. The new rate structure will take effect July 1, 2012.
- 2. AT&T DIA (Dedicated Internet Access) to MIS (Managed Internet Service) conversion project began a few weeks ago. Six locations are scheduled to be completed within the next two weeks. This service update will impact all DIA AT&T locations. Last month AT&T held conference calls with and sent out letters to the schools/districts and libraries across the state. This new service will not affect the K-12 Network in regards to cost. Just improved service quality.
- 3. Oconee County School District is in the early stages of transitioning off the K-12 Network.

- 4. Marion County Schools (1, 2 & 7) will be consolidated into one district next school year.
- 5. A flood of new DIA/MIS upgrades from K-12 Network members continue to be received by DSIT due to many wireless pilot programs being deployed across the state.
- 6. DSIT and Spirit continue to research solutions to address internet bandwidth underserved locations with less than the statewide 10 Meg baseline. The locations are as follows:

Direct Fiber Phase IV

1. Cherokee School District projects have been completed since last December.

2. The following districts have active projects. Some will be completed within the next two weeks.
