Agenda Item 2	Technology & Instructional Needs of Today's Schools	Presenter:	Dr. Terry Pruitt

- 1. Dr. Terry Pruitt, Deputy Superintendent with Spartanburg District 7 Schools, was on hand to give a presentation on how technology is being utilized in their schools.
- 2. The school district has been completely restructured over the last seven years.
- 3. The schools have a passing-rate between 75%-80% which is above the national average of 60%. They only district in the upper state with a SAP score of the national average.
- 4. The District has about 7,000 students with schools in areas with the least poverty rate as well as those in very impoverished areas.
- 5. Their goal was to have technology in every classroom site and sound therefore the teachers had access to technology. Next step was to get technology to the students.
- 6. They developed a program wherein they partnered with different organizations in the community to make the program a community not a school effort.
- 7. Where able to place a MacBook Air in the hands of all students in grades 6 -12 and give students in grades 3 -5 iPads.
- 8. Researched schools nationwide to get ideas as to how to establish and accomplish technology goals. Decided to use a school in Morrisville, NC as their benchmark. This school district is known nationwide for doing technology the right way.
- 9. They decided their goal was to equip their students with 21st Century Learning Skills. Four things that were very import: Children need to have good communication skills, be able to collaborate, have critical thinking skills and be creative.
- 10. In order for their program to be successful they hired specialist to educate teachers on how to use the technology and a technical person to keep the technology working.
- 11. Before a child is given a device he or she and a parent must learn Digital Citizenship which teaches you have to behave on a device.
- 12. For children that do not have access to broadband access at home, the school has provided a list of hotspots in the community.

• Adoption of the US Census definition of Urban Clusters (UCs) per US Census definition (populations 2,500 to 50,000). Many stakeholders recommend a modified version of this US Census definition (between 25,000 to 50,000 "Urban), Urban Clusters below 25,000 to be considered "Rural".

- Prior to the FY 2015 E-Rate Form 471 Application filing window USAC will provide a listing of all entities (school and library) and their corresponding designation. Feedback collected from this information posting will assist USAC with cleaning-up its database which will have a live link to the US Census database.
