1. DSIT continues to collect documentation to file for BEAR reimbursement later this Funding Year.

# 2012-13 (New Year) Application

- 1. DSIT is working on the remaining three E-Rate applications for DIA/MIS and WAN service.
- 2. DSIT is awaiting the posting of 45<sup>th</sup> day of school data via SCDE website.
- 3. DSIT is working on State LOA's and SCDE & SCSL are working on draft document covering 2013-14, 2014-15, 2015-16 will be needed by DSIT before the end of the funding year.
- 4. DSIT follow-up with USAC regarding their anticipated request for a new state eligibility certification letter and the current year validated NSLP data file from SCDE.

### **Network Changes**

- 1. AT&T DIA (Dedicated Internet Access) to MIS (Managed Internet Service) conversion project began last month. Six locations have completed installing. Within the next few weeks, 14 locations are scheduled to be completed. More than 51 K-12 School Network members remaining.
- 2. Oconee County School District is still in the early stages of transitioning off the K-12 Network. There are major project delays.

- 3. Plans are in progress to assist in the Marion County School's (01, 02, &07) consolidation into one district. The District is pursuing a very good direct fiber placement opportunity.
- 4. There has been a lot of feedback from K-12 Network Members regarding Internet service projected demand levels for FY 2012-13. DSIT is conducting a study to determine the needs and available options to pursue raising the current 10 Meg baseline. Demand has doubled and in some instances almost tripled on the K-12 School's Network.
- 5. DSIT and Spirit have secured a solution for five of the following six Internet bandwidth underserved locations with less than the statewide 10 Meg baseline. Barnwell 29 is still under review.
