E-Rate News

1. USAC initiated Phase I of the new online based E-Rate Productivity Center (EPC). This new online portal includes a mobile app for iPhone and Android devices (Appian software download required). This new tool will provide more electronic communications (news, contracts, forms filing). The first online form implementation was the FCC Form 470.

Whitehouse

1. **New ConnectHome Initiative**: The new initiative involves a pilot program designed to support Internet access at home for over 275,000 low-income households. This new program is designed to address the "Homework Gap". The program will offer "broadband access, technical training, digital literacy programs and devices for residents in assisted housing units.

K-12 Committee Projects

- 1. Palmetto Unified School District (DOC) Tyger River HS: Department of Technology is reviewing quotes received thus far.
- 2. SANS Training and GIAC Certifications Exam: 78 vouchers were distributed on 07/20/15.

State E-Rate Program Status

- 1. 2014-15 Current: E-Rate Funding Year (07/01/2014 06/30/2015)
 - a. Less than 350 vendor orders remaining. The majority of these orders are due to AT&T ASE projects.
 - b. Billed Entity Applicant Reimbursement (BEAR) forms filings are in process.

 - d. FCC Form 479 documents were sent to the State Department of Education and State Library for document retention.
