eRate News

- 1. USAC released the first two funding waves for FY2014 (July 1, 2014 June 30, 2015) totaling \$699 Million.
 - a. The record breaking first wave provided six times more high-speed broadband commitments than FY 2013.
 - b. A total of a little over \$21 Million in Priority-one service has been approved for SC.
- 2. FCC held an eRate Modernization Workshop. The workshop provided an opportunity for the Commission and eRate stakeholders to discuss the challenge of delivering high-speed connectivity to and within schools and libraries as well as highlight successful strategies. The following three program goals were the major focus:
 - a. Ensuring that schools and libraries have affordable access to 21st Century broadband that supports digital learning.
 - b. Maximizing the cost-effectiveness of eRate funds.
 - c. Streamlining the administration of the eRate program.

State eRate Program Status

2013-14 (Current Year) 07/01/2013 – 06/30/2014 Application

- 1. Two additional FCC Form 472s (BEARs) were filed. The five BEARs submitted last month have been approved by USAC-SLD.
- 2. Still working with the State Library and SC Department of Education in an effort to collect the few outstanding Technology Plan Approval Letters.

2014-15 (New) 07/01/2014 - 06/30/2015 Application

- 1. Applications are being processed by USAC-SLD.
 - Current Status: Four out of five were funded, the 5th application in final review status.
 - For the approved applications, FCC Form 486s were filed to acknowledge acceptance of these funding commitments.
- 2. Working on collecting MOU documents and placing vendor orders.

- 3. Draft Bandwidth Allocation Policies for Internet Access and WAN/LAN Network sent to SDE, EOC, State Library, SCETV for review and input.
- 4. Monitoring new and expiring state master contracts.

2015-16 (Upcoming) 07/01/2015 – 06/30/2016 Application

- 1. Assisting the State Department of Education (SDE) with USAC-SLD biannual certification of "Non Traditional Students and Facilities".
- 2. Assisting State Department of Education (SDE) with the implementation of the federal Community Eligibility Option: CEP (CEO) program transition as it relates to free and reduced lunch data collections impacting the eRate state data file (October 2014).

- 1. The following districts have completed projects: Lancaster

AT&T Platform Change-outs

- 1. The AT&T and Bellsouth Merger effective now.
- 2. AT&T is transitioning Legacy Bellsouth Service platforms to AT&T platforms.

As of May 21, 2014

- a. MIS (Managed Internet Service) Upgrade with 36 of 77 sites (47%)
- b. Metro-E to AT&T Services Ethernet Tower with 143 of 700 sites (20%)
 - Berkeley 18 sites complete
 - Greenville 61 of 86 sites complete (70%)
 - Charleston 65 of 85 sites complete (77%)
 - Lexington 5 and Richland 1 are stated for June

- 1. The VoIP solicitation will be executed around August/September 2014
- 2. Award anticipated by the end of this calendar year.
- 3. Existing contract expires March 26, 2015 and replacement will coincide with Fiscal Year dates

Agenda Item 4K-12 Security ProjectPresenter:Mark Hinsch

- 1. ISAC Report Card generation will resume when new methods and criteria are confirmed.
- 2. The Security Team has completed about 86 of 130 equipment exchanges/upgrades across the state.
- 3. 24 libraries and 9 charter/special school now have 10 mbps or greater of internet.
- 4. Successful testing with moving monitoring port to add-in NIC and/or upgrading the NICS in high speed servers.
- 5. Initial in-school testing of high-bandwidth server was successful so the roll-out will continue.
- 6. New installation and high-speed sites are far more labor/ resource intensive than upgrades/swaps.
- 7. Bill Croteau with The State Library is assisting with inter-library communications for upgrades and installations.
- 8. Several districts were unable to support new 10 GB fiber connections due to older equipment or all the fact that all the 10 GB ports were in use. The team will test 1 GB fiber trap with a district to see if this will be the best solution in these cases.

1. It is expected that we should know the appropriated amount to be given to the committee by July 1st. In the past couple of years the appropriation has been 10 million.
