- 1. Connect South Carolina is a subsidiary of Connected Nation and operates as a non-profit in the state of South Carolina. Connect South Carolina was commissioned by the Office of the Governor to work with each of the state's broadband providers to create detailed maps of broadband coverage and to assess the current state of broadband adoption, community-by-community, across South Carolina.
- 2. Connect South Carolina is working to ensure that all can experience the benefits of broadband. Technology, especially widespread access, use, and adoption of broadband, improves all areas of life.
- 3. Connect South Carolina's core activities are:

- 4. There is an increasing need for Broadband in the United States. The current benchmark for broadband is 25 Mbps for Download speed and 3 Mbps for Upload speed.

 - c. In contrast, only 8% of Urban America lacks access to these benchmarks.

1. Palmetto Unified School District (DOC) Tyger River HS: Economical solution identified and final cost estimates are being collected for project implementation. Project estimates will be completed during the month of November.

State E-Rate Program Status

- 1. <u>2014-15 Old: E-Rate Funding Year (07/01/2014 06/30/2015)</u>
 - a. Department of Technology had a USAC/KPMG initial BCAP Audit conference call on 10/15/15. Initial documentation requested by KPMG was provided on 10/20/15.
 - b. Final Billed Entity Applicant Reimbursement (BEAR) forms have been submitted for processing by USAC.
- 2. <u>2015-16 Current: E-Rate Funding Year (07/01/2015 06/30/2016)</u>
 - a. Approximately 301 vendor orders are remaining. The vast majority of orders are due to AT&T ASE projects.
- 3. <u>2016-17 Upcoming: E-Rate Funding Year (07/01/16 06/30/17</u>
 - a. Division of Technology is working with the State Department of Education to prepare State E-Rate Data files.
